<p>COGCC Inspection Report Summary On Friday 6/10/2022 at approximately 12:30 hours, I, Inspector Tom Peterson, conducted an on-site inspection at the Expedition Water Services EWS 3A well API #123-43880 in Weld County, Colorado. While there, I observed that the well lacked mechanical integrity. Operator immediately ceased injection operations. During this inspection the following possible compliance issues were observed: Rule 417.f. with a corrective action date of 6/10/2022. A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
