General Comment:

Operator informed Commission of disposal of water to "Extreme Hot Oil (which I considered as a commercial disposal as they hauled the water) used the water in its operation and did not take to a commercial disposal well." This method of disposal is considered Produced Water Reuse and Recycling and falls under Rule 905.b.(3).

This inspection is to follow up and document disposal of produced water.

Operator shall provide all information pursuant to Rule 905.b.(3): Produced Water Reuse and Recycling. Operators may reuse produced water for enhanced recovery, drilling, completion, and other approved uses in a manner consistent with existing water rights and in consideration of water quality standards and classifications established by the WQCC for Waters of the State, or any Point of Compliance established by the Director pursuant to Rule 914.

Operator does not have a Waste Management Plan (WMP) on file. Pursuant to Rule 905.a.(4) Operator shall submit a WMP. See corrective actions.

905.a.(4): Waste Management Plans. Each Operator that generates E&P Waste as a result of their operations will prepare a comprehensive waste management plan detailing how the Operator will treat, characterize, manage, store, dispose, and transport all types of waste generated. The Director may require a waste management plan to include a description of proposed haul routes, including any applicable Local Government traffic requirements.

A. Operators will submit their waste management plans with their Form 2A pursuant to Rule 304.c.(11).

B. Operators will evaluate opportunities for reuse and recycling and may include a reuse and recycling plan, as described in Rule 905.a.(3) above, as part of the waste management plan.

C. If an Operator seeks to change its E&P Waste management practice, the Operator will update its waste management plan by submitting a revised waste management plan for the Director's approval or denial on a Form 4.
