Comment: There was an area along the former access road that has not re-established perennial vegetation and consists of weeds. A portion of former road to the northeast was not inspected. The remainder of the road to the location has re-established perennial vegetation. The location has been recontoured and reclaimed and vegetation has established throughout most of the location. Additional reseeding and weed control is needed along the access road. The entire access needs to be evaluated for possible reclamation maintenance.
