Comment:	It was observed in this inspection that one musk thistle (List B Noxious Weed) is present on Location. Inspector removed the plant. Cheatgrass (List C Noxious Weed), Russian thistle, kochia and field brome (undesirable plant species) are also widespread and dominant in multiple areas of the Location. Field bindweed (List C Noxious Weed) is also widespread. A fall corrective action date is being given to allow for appropriate treatment of cheatgrass. Operator is encouraged to control weeds as quickly as possible, but also to determine the best method of weed control and implement at the appropriate time.		
Corrective Action:	Conduct weed management to prevent further establishment and spread of noxious weeds and undesirable plant species; ongoing weed management required until location passes final reclamation.		Date: <u>11/15/2022</u>

	<p>Refer to the "Location" section of this inspection report for weed control corrective action.</p> <p>It was observed in this inspection that the access road and areas at the northeast, southeast and several other areas of the Location are not progressing towards non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. These areas have few perennial species present and are dominated by annual, noxious weeds and undesirable plant species.</p> <p>Additional reclamation is necessary. Per document #1159748, reclamation on this Location began approximately 01/01/05.</p>	
Corrective Action:	<p>Comply with 1004 Rules.</p> <p>Conduct additional reclamation in accordance with COGCC 1000 series rules. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
