Plan needs to include a detailed description of the extent of the weed infestation, what weeds are observed along the right of way, how they will be controlled, and treatment schedule. The plan should also include a monitoring schedule as well as treatment goals and dates. Areas where desirable vegetation is effected by weed control, will need revegetation.

-Revegetation needs to be conducted in portions of the right of way where sparse desirable vegetation is present. Erosion controls such ecofiber mulch, or straw/hay mulch are needed until stabilized with desirable vegetation. Livestock exclusion will likely be needed in these areas until vegetation is established. CA:11/20/2021.
