Previous inspection #702800200 observed impacted soils adjacent to the pumpjack to the southwest and throughout the tank battery secondary containment. Operator submitted FIRR #403076630 stating CA Completed "PU leak tightened, connectors tightened, oily soils removed."

At the time of this inspection no stained soils were observed at the pumpjack or in the tank battery secondary containment. This corrective action has been addressed.

Comment: [Previous inspection #702800200 observed insufficient stormwater and sediment control BMPs in place. Inspector required Operator to install or repair required BMPs per Rule 1002.f. 6/13/2022. Operator submitted FIRR #403076630 stating "filled eroded areas, added more wattles"](#)

[It was observed in this inspection that wattles have been reinstalled at the west of the Location. Wattles were shallowly trenched and backfilled with a small amount of sediment. Adjacent wattles were overlapping. This corrective action has been addressed, however, it is unclear if the wattles are sufficient to manage stormwater on the Location, as this control measure failed previously. Inspector suggests regular monitoring and maintenance of control measures.](#)
