Operator Comment: 603.o is not applicable to produced water tank on Garcia 1 location. 603.o is only applicable to "new and significantly modified crude oil, condensate, and produced water storage Tanks."
However, Oxy will install an earthen berm and straw waddles around the perimeter of the location as a secondary containment mechanism while excavation work is ongoing. Oxy will commit to completion of this work by 6/24/2022
Oxy is evaluating permanent containment options around the produced water tank once excavation activities are complete.
