INITIAL ACTION SUMMARY

The COGCC Orphan Well Program will be plugging the Buckeye (OWP) #2 well and decommissioning any associated on location flow lines and/or production equipment. Soil samples will be collected in accordance with COGCC Rule 915.e(2)B. Samples will be collected from the wellhead excavation, flow line path(s), as well as any other area likely to have been impacted. Samples will be submitted for laboratory analysis of Table 915-1 constituents.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil samples will be collected for laboratory analysis of Table 915-1 constituents from areas most likely to have been impacted. Visual inspection and field screening of soils will be conducted in the areas surrounding the flow line(s) if present, and the well head. Based on these observations, soil samples may be collected and submitted for laboratory analysis of Table 915-1 constituents. Discrete soil samples will be collected for confirmation of compliance with Table 915-1.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If a pathway to groundwater is discovered or groundwater is encountered during remediation activities, a sample(s) will be collected and analyzed for Table 915-1 constituents and notice given to COGCC EPS staff.

Base line surface water samples will be collected prior to any surface disturbance. A sample of the fluid on the surface near the wellhead will be analyzed for Rule 615.e.(2) and Table 915-1 constituents. Samples from the Larkin Ditch (upstream and downstream of the confluence of any apparent drainage features) will be analyzed for Table 915-1 constituents, assuming that the irrigation ditch is flowing.

Additional Investigative Actions

If baseline water samples indicate exceedances of any Table 915-1 organic compounds in groundwater, fluids encountered during implementation of this proposed REM Project will be collected and disposed of at an approved facility. Environmental	<p>COGCC Inspection Record documents that the well has been discharging produced water and methane to Larkin Ditch with a potential wetland around wellhead dating back to 4/24/2016 (doc #680100756). Given the presence of shallow groundwater (<20' below the surface indicated under Site Conditions), likelihood of seasonal variability in depth to groundwater, and documented threats to both groundwater and surface water from produced water discharge, this project is subject to Table 915-1 Protection of Groundwater SSLs.</p> <p>Additional soil sampling may also be required from produced water discharge area per Rule 915.e.(2).B. The current Form 27 only indicates that one sample will be collected from the base of the wellhead excavation.</p>	03/30/2022
