Corrective Action:	<p>It is unclear if compaction alleviation (cross ripping to a minimum depth of 18 inches) was performed per 1004 Rules. Soil penetration with a shovel was very difficult. Soil peds were large and dense and structure showed evidence of compaction.</p> <p>It appears the Location may have been seeded with smooth brome and intermediate wheatgrass. At the time of this inspection, there is little evidence of germination of seeded species. Additional time may be required for desirable plants to establish.</p> <p>Trash was present on Location. Debris, including multiple cables, cut at the ground surface remain buried on site. An anchor and marker remain at the south of the Location.</p> <p>Comply with 1004 rules: Remove all remaining equipment and trash/debris. Perform compaction alleviation (cross ripping to a minimum depth of 18 inches) or provide documentation of compaction alleviation if this work has already been completed per 1004 Rules.</p>	Date 08/04/2022
