Comment Sundry #400900591 states IR is complete; it was observed in this inspection that this location does not meet reclamation requirements; insufficient vegetative cover. Transects were conducted indicating vegetation is not 80% of the reference area; interim areas are predominantly an annual cheat grass monoculture with pockets of perennial wheatgrass species.

Corrective Action Comply with 1003 rules and conduct additional reclamation. Comply with Rules 1002.c, 1003.f, and implement BMPs to prevent weed establishment.
