Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the HOFFNER 13-35 wellhead cut and cap. The wellhead was cut and capped per COGCC rules. The flowline was previously abandoned on 4/2/2018, and the COGCC was notified on Form 44 Document number 402263524.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
