Comment Jointed goatgrass, a CO List B Noxious weed was observed at the south of the Location. A fall corrective action date is being given to allow for proper treatment of this species.

Areas of the location not needed for production, or no longer in use have been reclaimed. Interim areas are vegetated with Russian wildrye and tall, crested, and intermediate wheatgrass (non-native perennial grasses). Galletta and alkali sacaton (native perennial grasses) are present at the south of the Location. There are occasionally portions of the interim area where seeding has failed and kochia (annual undesirable plant species) and cheatgrass (List C Noxious Weed) dominate. At the time of this inspection perennial grasses dominate the interim areas.

Corrective Action Conduct weed management to prevent further establishment and spread of CO List B Noxious Weeds; ongoing weed management required until location passes final reclamation.
