INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Investigation of material placed in SR 698-27-01 (27-1) central cuttings pit is pending approval. Historical aerial images from time of active use were reviewed in developing this closure sampling approach. See attached Figure 1 for areas within the pit where cuttings and frac sand were originally placed. It appears the material was spread out across the base of the pit as drilling operations ceased and is now supporting some vegetation. Import material thickness is not expected to exceed 10 feet.

The pit base will be assessed in 3 areas (north, south and west) primarily based on import material type identified on Figure 1. The locations on Figure 2 will be geoprobed or potholed using backhoe and field screened using a photoionization detector. Thickness of import material and approximate depth of native soils will be noted. Two (2) grab samples from each assessment area (total of 6) will be collected at locations of highest PID readings. At locations where import material exhibits the highest PID readings, the native soil beneath will be field screened and sampled also. All samples will be analyzed for Table 910-1 per 915.f.
