Pursuant to COGCC Rule 911 a site investigation was conducted at the WEBSTER 15-28 wellhead cut and cap and flowline removal. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead was cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

Twelve soil samples were collected during the site investigation. Soil samples were analyzed by a certified laboratory for GBTEXN, TPH (total volatile [C6 -C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron.
