<p><b>COGCC Inspection Report Summary</b>  <b>**Weather Conditions: sunny, dry ground</b>  On Tuesday, July 19, 2022 at approximately 14:00, I, Inspector Brittani Santistevan, conducted an on-site inspection at WALT 25-D PAD (Extraction Oil &amp; Gas), at location #: 441528 in WELD COUNTY Colorado.  While there, I observed a shut in facility.  During this inspection the following possible compliance issues were observed:  1. Multiple unused/disconnected equipment near wellheads. Reconnect or remove equipment per Rule 606. (Corrective Action Date: August 20, 2022) See attached photos #2 -5, 7, 9-16, 19, 22-25.  2. Stained soil on various areas of wellhead location. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.(2).d. (Corrective Action Date: August 20, 2022) See attached photos #6, 13, 20.  3. Storage of chemicals at one wellhead. Remove to comply with Rule 606. (Corrective Action Date: August 20, 2022) See attached photo #14.  4. Multiple wellheads do not display signage. Install sign per Rule 605.d. (Corrective Action Date: August 20, 2022) See attached photos #8, 17, 18, 21.  5. Debris/weeds on various areas of location of tank battery. Remove to comply with Rule 606.
