While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. It appears to be stained soil under master valve. Conduct maintenance on equipment, cleanup stained material and review self inspection processes per Rule 1002.(2).d. (Corrective Action Date: August 16, 2022) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
