Comment:

The location has not been reclaimed and soils are compacted. There is an access road that travels thru the location that will need to remain however, disturbed areas of the location need to be reclaimed as stated in the previous inspections. There is approximately 0.4 acres that needs to be reclaimed back to cropland production. Soils must be decompacted by crossripping to a minimum depth of 18 inches. There is asphalt debris and trash remnants left on location that need to be removed. The previous corrective action has not been completed. Corrective action must be completed immediately.
