On 07/26/2022, Reclamation Specialist O'Malley conducted a reclamation and stormwater inspection at Beeman Oil & Gas LLC's Welker 6-92 /1-2H11 Location #438580 in Moffat County, Colorado.

This is a follow up inspection to document #702800198.

The following compliance issues were observed during this inspection:

- Safety labeling inadequate
- Debris: concrete & weeds
- Storage of supplies/equipment
- Stained soils
- Wildlife protection BMPs absent
- Unmarked guy line anchors
- Interim reclamation not performed
- Noxious weeds

## Comment

Previous inspection #702800198 observed noxious weeds were present throughout the Location. Inspector required Operator to conduct weed management by 5/26/2022.

It was observed in this inspection that noxious weeds are widespread on the Location and there is no evidence of weed management. Species include scotch and Canada thistle, cheatgrass, houndstongue and spotted and diffuse knapweed. Original corrective action and date remain applicable.

It was observed in this inspection that interim reclamation has not been performed. Interim reclamation was required to be performed by 5/1/2022.

## Corrective Action

**CORRECTIVE ACTION #1:** Conduct interim reclamation on the Location per 1003 Rules including, but not limited to: gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities; use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.
