On Friday, August 5, 2022 at approximately 11:00, I, Inspector Brittani Santistevan, conducted an on-site inspection at HSR-VETTER 12-36 (PDC Energy), at location #: 330485 in WELD COUNTY Colorado.

While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. Overgrown weeds inside wellhead fencing. Remove to comply with Rule 606. (Corrective Action Date: May 2, 2022) See attached photo #2.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
