COMMENTS:

Locin is requesting approval to squeeze off the upper set of perforations in this well. The intended zone to isolate is 1794 – 1800' in the Castlegate formation only. This well was a dual completion well with two strings of tubing in it. Locin intends to then re-complete the producing formation of the Mancos. A subsequent report Form 5 will be submitted upon completion of the operation.

1. Pull dual string
2. Set RBP and RIH with cementing string with cement retainer.
3. Squeeze castlegate perforations from 1794' – 1800' using ~20 sacks of cement
4. Add perforations/re-perf from 2964' – 3060'
5. RIH with 3.5" working string and packer
6. Re-Frac Mancos B
7. Flowback and test
8. Remove workstring. Run 2-3/8" tubing setting at ~3071'
9. Return to production

1. Operator shall comply with the most current revision of the Northwest Notification Policy.
2. The Operator shall monitor the bradenhead pressure of the proposed well and all offset wells under Operator's control which penetrate the stimulated formation and have a treated interval separation of 300 feet or less. Monitoring shall occur from 24 hours prior to stimulation and shall continue until 24 hours after stimulation is complete. Recording shall be at a frequency of at least once per 24 hours with the capability of recording the maximum pressure observed during each 24 hour period. Operator shall notify COGCC Engineering staff if bradenhead pressures increase by more than 200 psig.
3. Submit a Form 5 within 30 days of the work with job related documents including a minimum of one of the following attachments: operations summary, cement job summary and/or wireline summary. Additionally, include CBL's and any additional logs run.
