Additionally, the access roads have not been reclaimed (e.g. recontoured or regraded). Refer to inspection photos.

Operator shall conduct reclamation activities per 1004 Rules and continue to monitor and manage the location until it complies with 1004 Rules. This includes but is not limited to, recontour, regrade, and decompaction of access roads, and performing reseeding on disturbed areas in order to achieve at least 80% uniform vegetative cover reflective of pre-disturbance or reference areas.
