Operator Comment: 27-1 CUTTING PIT RECLAIM DIRT WORK WAS STARTED ON 3 MAY 2022 AND COMPLETED ON 7 JUNE 2022. THE PIT WAS FILLED IN TO GRADE AND THE SURROUNDING AREA WAS CONTOURED TO NATURAL CONTOUR. ALL STORM WATER BMP'S INSTALLED.

TOPSOIL WAS SPREAD ACROSS THE ENTIRE LOCATION AND IS READY FOR THE ADDITION OF SOIL SUPPLEMENTS AND SEEDING. ADDING SOIL SUPPLEMENTS AND SEEDING WILL TAKE PLACE IN THE FALL OF 2022 TO ENSURE THAT SEED MIXTURES HAVE SOME MOISTURE TO HELP WITH GERMINATION.

COGCC Decision: **Not Approved**

COGCC Representative: Per inspection #696203854 dated 7/14/2022, work to reclaim the pit was observed, however, it was also observed, and confirmed through conversations with Chevron, that reclamation work (including seeding) has not been completed in accordance with COGCC 1000 series rules. Operator indicated seeding will be performed later in the year.

Stormwater controls also observed to not be per good engineering practices.

Location will remain out of compliance until CA has been addressed in its entirety.
