General Comment:

on 8/8/2022 COGCC staff, Kris Neidel inspected spill 482698 at the Maudlin Gulch #12 injection well. The spill was reported by the operator. At the time of inspection the following was observed; no free fluid (spilled fluid) was present, the failed pipe had been excavated, the failure was observed and photo documented, it was told to COGCC by Wesco pumper that the spill was discovered during normal well checks, after the spill was discovered, the pumper went down to the pump to shut the pump in, it was told that the well was injecting below 200 psi, it was told to COGCC that no pressure was observed on the backside of the well. The spill was observed as fluid daylighting on the surface. Wesco has filed a Form 19 and has stated that they are collecting soil samples to confirm compliance with Table 915-1. No other equipment on location, other than IJ well. see attached photos.
