On Wednesday 8/17/2022 at approximately 1000, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Stranahan 21B, at Location # 335440 in Garfield county Colorado.

Any Corrective Actions from previous Inspections that have not been addressed are still applicable.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.

C/A (stored equipment) has not been completed from document # 700703012. FIRR documents # 402790442 and #402769650 states C/A has been completed. Therefore C/A date remains the same.

During this inspection the following possible compliance issues were observed:

1. Storage of equipment (ECD is disconnected from all lines)
2. Sediment migration from location at entrance of location

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
