On Thursday, August 18, 2022 at approximately 09:45, I, Inspector Brittani Santistevan, conducted an on-site inspection at BUNN 1-35 (PDC Energy), at location #: 319270 in WELD COUNTY Colorado.

While there, I observed a shut in wellhead.

During this inspection the following possible compliance issues were observed:

1. Over grown weeds surrounding wellhead inside fencing. Remove to comply with Rule 606. (Corrective Action Date: September 1, 2022) See attached photo #3.

A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
