Comment: There are areas along the road that will require additional BMP's and maintenance. There are areas of erosion that need to be repaired and stabilized. The rock check dams have been reinstalled since the previous inspection. Some of the check dams are in need of maintenance due to stormwater flowing around the outside. There is a culvert along the road that has filled in with sediment causing stormwater to flow down the road. There are stormwater diversion ditches that have filled in with sediment causing stormwater to flow down the road. BMP's must be implemented in accordance with good engineering practice and must be maintained.
