Operator Comment: The Hott 20-2 1 well (067-06629) plug and abandonment downhole actions are not complete and the associated Form 6, which finalizes the P&A status and starts the timeline for the flowline and equipment stripping, is not approved. IKAV Energy/SIMCOE is in active conversations with COGCC Engineering Staff, A. Duran, regarding the status of the well. The anticipated timeline for approval of the Form 6 is after September 30, 2022. The loose items and debris will be addressed per the timeline in the CA.

COGCC Decision: Approved

COGCC Representative: Form 2 still in process, no drilling should commence with out approved Form 2

COGCC Supervisor: Monitoring well for continued gas pressure
