Comment:

This location does not meet reclamation requirements; access road remains. The Location access road has not been adequately reclaimed. Vegetation growth is absent in tire tracks where soils are compacted and bare. Vehicles appear to be utilizing the road and driving onto the Location. The access road must be reclaimed per Rule 1004.a.

This Location is on Fed surface. If available, submit an approved Final Abandonment Notice (FAN) in an FIRR indicating surface reclamation has been passed per Bureau of Land Management standards. Or, submit documentation indicating the access road shall be left open per BLM.

At the time of this inspection vegetation on the Location is progressing towards 1004 standards.

Corrective Action: **Comply with 1004 Rules. Close and reclaim the access road. Revegetation activities shall be completed no later than 11/15/2022.**
