Note- there is a potential source of fill material adjacent to the well location.</p> <p style="color: blue;">Well location- This would not need to be recontoured but weed maintenance will be required.</p> <p style="color: blue;">Access road- Based on historic aerial imagery, Operator reclaimed the access road but the surface owner is using it to access a stormwater management area.</p>	Date 11/14/2022
	<p style="color: red;">Comply with Rule 1004.a to recontour the tank battery portion of the location.</p> <p style="color: red;">Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil.
