The Site Investigation and Remediation was originally initiated by Babcock & Brown, who sold the related facilities to Legado in 2008 who sold to Benchmark in 2011. COGCC added Pit Facility ID 116315 as a related facility based on a review of the records in that file that indicate the location at the former Graylin D production facilities.
