During this inspection the following compliance issues were observed: 1) Unused equipment with a corrective action date of 10/14/22. 2) Loadline open ended with a corrective action date of 9/20/22. 3) Sediment is encroaching on equipment. Run on to location is not being controlled with a corrective action date of 9/29/22. - Location is located in a high priority habitat area. A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
