Comment:

	<p>This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 06/09/2003. It appears reclamation activities have been performed; however, during this inspection the following issues were observed- annual weedy vegetation (e.g. russian thistle) within the reclaimed area, non-uniform vegetation cover resulting in bare soil, and the access roads have not been recontoured or graded to reference area levels. Refer to attached inspection photos.</p>	
Corrective Action:	<p>Comply with Rule 1004. Operator shall regrade and recontour disturbance areas including but not limited to access roads, and perform compaction alleviation by cross ripping to a depth of 18" to prepare an adequate seed bed. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p>	Date 11/15/2022
