Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

This well completed in May 1955 as a "D" sand oil well and has a cumulative of 184,789 barrels oil. On last AVT 12-29-63 the production was no oil and 78 barrels water in 24 hours and has been shut in since that time.  
 It is proposed to cement squeeze the "D" sand at perforated intervals 5447-52, 5457-60 and 5470-80, perforate the "J" sand interval 5562-66, top of which is at 5555 per Schlumberger, clean out and swab test for conclusive production. The estimated recovery from "J" sand is 5600 barrels oil. Your permission is requested.
