INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

This well completed as a "D" sand producer in May 1955. The well watered out in November of 1963 and an attempt to recomplate in "J" sand was not successful so has been shut in since that time. It is now proposed to plug and abandon by setting a rock and cement bridge above perforations, shoot off casing at free point and pull, fill hole with heavy mud with cement plugs in bottom and top of surface casing, weld steel plate on top of surface casing, clean up, grade and abandon location.

NOTE: Bid letters have been sent to used equipment dealers for net salvage bids on equipment in this well and whether we sell for salvage or plug it ourselves; Your Office will be contacted prior to start of plugging operations.
