This well was completed as a "D" Sand producer on April 29, 1955.
All possible zones of production have been depleted, and we propose to plug and abandon the well per state regulations as follows:

We plan to pea gravel pack across "D" Sand perforations at 5702-11', spot 10 sacks of cement on top of pea gravel pack and shoot of 5½" OD casing at approximately 4600' & pull casing. 10 sack cement plugs will be set at both the top and the bottom of the surface casing and a 1/4" steel plate will be welded on top of the surface casing 18" below ground level. All equipment will be removed from the well site and the location cleaned & leveled.
