Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 11/10/2011. During this inspection, COGCC Staff observed an area approximately 10' x 10' in size near the well location that was void of vegetation and subsided. This area was not reflective of the reference area crop (e.g. corn). Refer to attached inspection photos.
