Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 03/31/2018. During this inspection, COGCC Staff observed that the reclaimed area was not reflective of reference area perennial crop (e.g. sugar beet). Staff observed non-uniform vegetation cover resulting in bare soil and annual weedy vegetation throughout the disturbance area. Refer to attached inspection photos.
