#### Technical Detail/Comments:

- 1). Form 42 was submitted prior to plugging operations, Form 42 Doc #403022419. Form 42 was submitted prior to MIRU for plugging operations, Form 42 Doc #403022428
- 2). After placing plug at 7400', operator waited a sufficient amount of time to confirm static conditions. There was no pressure or fluid migration.
- 3). No fluids or gas migration was present prior to cement plug to surface being set. The plug was cemented to surface with 115 sacks of cement from 250'.
- 4). Plug was cemented to surface and topped off w/ 20 sx at surface (Total sx 135).
- 5). At least 100' of cement was left in the wellbore for each plug.
