Comment: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 04/27/2020. It does not appear reclamation work has been performed; the well location has not been recontoured/graded; the tank battery location has not been reclaimed; weedy, annual vegetation was observed which includes but not limited to russian thistle, field bindweed, and kochia. A List C CO Noxious weed, Field Bindweed, was observed at the location.
