The Well is located 2373 Ft. (N) of Section Line and 2369 Ft. (E) of Section Line. (S) (W)

The elevation above sea level is 4214' KB 4202 grd Ft.

Details of Plan of Work: (State names of and expected depths to objective sands. Show sizes, weights, and length of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work.)

The above described well was completed in Dakota "J" sand with perforation from 5016-33' KB on 7-26-53. Initial production was 148 B.O. and 140 B.W. Well was shut in 10-31-55 when production was zero and no fluid was found in hole.

Servicing unit was moved in and well casing swabbed dry on 1-20-56. Shut in well and checked for fill-up and the casing swabbed dry again. 500 gal HCl was dumped in well, followed by 60 bbls crude oil and well shut in. Casing swabbing was resumed on 1-22-56 to recover load oil and spent acid. Well was placed on pump 1-24-56 for testing. Average production during 10 day test: 9.3 B.O., 3.3 B.W.
