	This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland; well was plugged 05/06/2019. It does not appear any reclamation work has been performed at the time of this inspection; access roads and location have not been contoured or regraded; non-uniform vegetation cover resulting in bare soil; straw wattles and perimeter fencing remain in place and are now considered debris; and Colorado List C Noxious Weed (Field Bindweed) was observed throughout the location and access roads.
