Comment: The well pad, tank battery and associated access road does not comply with Rule 1004. Majority of both disturbance pads and access roads show stunted crop growth and do not appear reflective of the reference areas. Site investigation into why the crops are stunted is required.

Corrective Action:	<p>Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
