Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district.

Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be completed no later than 11/15/2022.
