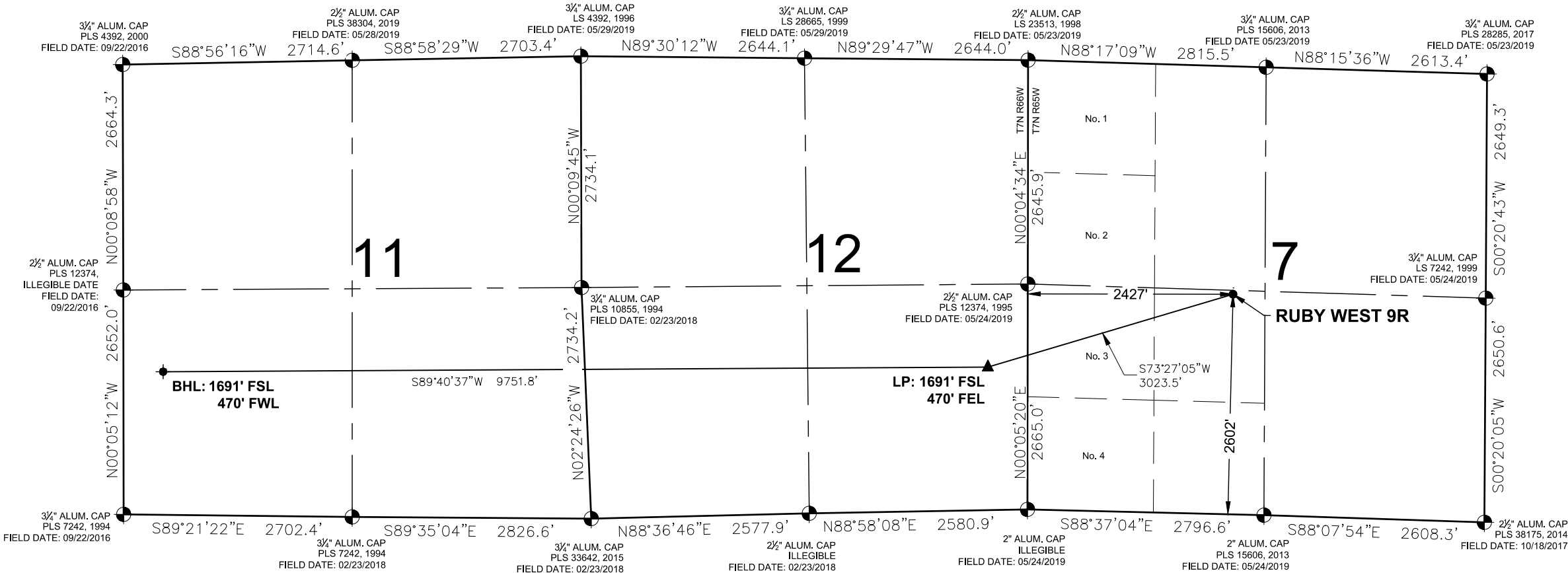


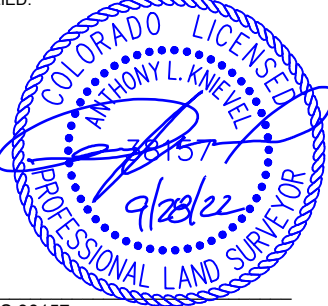
RUBY WEST 9R

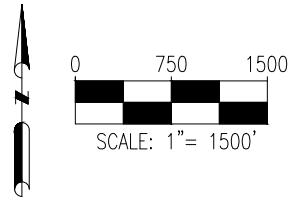
