Comment: The well location and access road appear to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances.

The tank battery and associated access road does not comply with Rule 1004. Gravel and a culvert remain at the tank battery access point.
