#### OPERATOR COMMENT AND SUBMITTAL

Comment: Regarding the inspector's comment regarding the partially buried tank: the on location SIMCOE tank is functioning as designed, has secondary containment in place, and the hatch is latched. When the tank is in use for produced water service the activity is a manned operation. The diamond patterned expanded metal access cover is designed to allow an easier visual check for tank level management. Under normal operations, this site's produced water directly flows to the water pipeline system and not the tank.  
Note the FIRR #403182805 was submitted 10/3/2022, however it was discovered later the attached document #403185037 weed and seed report and photos had errors (some photos were of another site). Per C. Pesicka, FIRR #403182805 has been deleted and this new FIRR is submitted to correct the attachment.
