Comment

There are noxious weeds along the access road and at the location. Observed Musk thistle, Leafy spurge, Scotch thistle, and Mullein. It is recommended that the operator consult with the local weed control agency or other weed control authority when weed infestation occurs. It is the responsibility of the operator to monitor affected and reclaimed lands for noxious weed infestations. Since the growing season is coming to an end ongoing weed control will need to be conducted more thoroughly next spring/summer. Previous corrective action was not completed.
