All WI owners have now approved the abandonment of the above captioned secondary recovery unit. This is the only Federal Well involved. It is economically infeasible to operate. Work will be done as soon as possible, weather permitting. No other sands productive.

Plugging Instruction:  
1.) Run sand over perforations plus 8 sks cement = 107.53 ft. on top of sand.  
2.) Fill with 10# mud to 5350'.  
3.) Set 11 sks cement plug from 5350 - 5200.  
4.) Find free point and cut pipe.  
5.) Fill to 4900' W/10# mud and pump 60 sks cement from 4900' to 4700'.  
6.) Fill to 188' W/10# mud and run 15 sks of cement 1/2 in 1/2 out of surface casing to 144'.  
7.) Run 5 sks. plug at surface W/a welded steel plate on the stub; cut off 3' below the surface.

This well is not ready for final inspection but will be rehabilitated as soon as possible.
