Comment: Insufficient stormwater and sediment control BMPs in place; rill erosion observed to the southwest of the separators, at the BMP which appears to be intended to discharge stormwater from the Location. The BMP does not appear to have been constructed with proper planning or good engineering practices to minimize erosion, transport of sediment offsite, and site degradation.

Corrective Action: Install or repair required BMPs per Rule 1002.f. Continue to monitor and manage stormwater on the Location. Ongoing stormwater management is required until the site receives a passing final inspection.
