Comment: Insufficient stormwater and sediment control BMPs in place; rill erosion and degradation to the eastern slope of the Location was observed. A rip rap lined slope drain was observed at the center of the slope and soils are sparsely vegetated with perennial grasses which appear insufficient to stabilize the slope at the time of this inspection.

Corrective Action: Install or repair required BMPs per Rule 1002.f. Continue to monitor and manage stormwater on the Location. Ongoing stormwater management is required until the site receives a passing final inspection.
